#### **GRANT and LOAN APPROVALS**

Amy and Casey Sons – Strand Theater 115 E. Michigan Ave submitted a letter and documentation to request **re-submission** of their grant approved in February 2018 as the scope of the original project had changed so that grant paperwork and documentation reflected such. The committee determined that a new grant <u>form</u> should also be filled out to avoid confusion before a recommendation for approval could be made.

The Grant review committee reviewed the grant request A grant request from Patrick Warner for \$2,250 for exterior doors was that had been tabled pending clarification documentation.

**A MOTION** was made by Steve Racette and **SUPPORTED** by Barbara Carpenter to approve a grant of \$2,250.00 to Patrick Warner for replacement and installation of custom sized exterior door at Warner Vineyard @ 706 S. Kalamazoo St. **MOTION CARRIED.** 

A MOTION was made by Steve Racette and SUPPORTED by Cindy Mount to approve a grant of \$3,925.00 to Ginger Smietana @ -111 S. Kalamazoo St. for roof replacement in conjunction with work being done to the roof at 210 E. Michigan Ave. (Adjoined roof) MOTION CARRIED.

## **Ongoing Business**

Roman presented an increase in cost of the Wine and Harvest Fireworks of \$750 this year due to increases in the product cost from China. It was discussed and acknowledged that there have been no costs increase in many years. To add to this Sarah presented a request for an increase in festival support of \$6,000 to cover admin costs.
