### **MEETING MINUTES**

Sarah reported reviewed the wayfinding sign information with the board. The company that is giving us a proposal is Valley City Sign. They were also the most recommended by other communities and only RFP returned. There were no negative reports found regarding their work. Their goal is to pick up on some of the elements of the streetscape design. They are very familiar with MDOT standards and permits. We are looking at approximately 3 months to design and then manufacture and install. They can coordinate with the Streetscape project. There was discussion about the 210 building renovations.

Sarah collected priorities sheets for long term goal discussion and asked board members to be prepared to discuss long term goals at the next meeting in November.

Mary gave a report on the progress of the Business Retention Grant application process. There was discussion of a Holiday Biz Buck give away to start in November before Small Business Saturday.

**A MOTION** was made by Kim Otten to approve \$4,000.00 for Biz Bucks Campaign **SUPPORTED** by Barbara Carpenter. **MOTION CARRIED.** 

Mary also asked the board if they would consider a new business incentive program or grant. Gary Barton had asked that it be considered to draw new business (as well as others over the years).

Mary went over plans for Social Distanced Visit with Santa plans. All is dependent on the covid numbers moving forward. But a good plan is in place at this time and moving forward tentatively.

Mary also announced that fall decorating was completed under budget.
