I have called Severance Electric about the banner rods that are supposed to come with the Kalamazoo Street poles. The rods were too large for our banners so Brian is having rods the correct size manufactured.

Touch a truck event is all set for both Paw Paw Days and Wine and Harvest Festival We have 8 confirmed at this time with one possible.
